Are Canada's counter tariffs affecting energy trade?

Similarly, Canada's counter tariffs have generally avoided most energy equipment imports. On March 7, 2025, President Trump first implemented a carve out such that all CUSMA-compliant energy trade will not be effected by the tariffs.

How have US tariffs impacted Canada's energy exports?

To date, U.S. tariffs have largely circumvented Canada's energy exports, including oil, gas, uranium and electricity. Similarly, Canada's counter tariffs have generally avoided most energy equipment imports.

Did Canada impose tariffs on fresh produce?

fresh fruit, vegetables, and nuts. On March 12, 2025, the U.S. imposed tariffs of 25% on Canadian steel and aluminum products. Canada immediately applied retaliatory tariffs on nearly \$30 billion worth of U.S. exports. This round of tariffs did not include any fresh produce exports.

How will Canada's tariffs affect international trade?

International trade is a key component of Canada's economy, accounting for two-thirds of GDP and supporting one in six jobs. With 75-80% of Canadian exports historically destined for the U.S., the tariffs are expected to reduce economic output, employment and the value of the Canadian Dollar. Canadian governments responded swiftly.
