# How much is the export tariff for energy storage cabinets in Lesotho

What is the tariff rate for imports from Lesotho?

The current tariff rate for imports from Lesotho is 15%. However, this rate can vary depending on the specific product category and any applicable trade agreements or exceptions. How do Lesotho tariffs affect import costs? Lesotho tariffs directly increase the cost of importing goods by 15% of the product value.

What percentage of GDP does Lesotho impose?

Lesotho, Exports of goods and services as percentage of GDP is not available. Tariffs imposed by Lesotho in 2022 are below. The maximum rate of tariff in percentage on any product is 60. The simple average tariff across all products is 4.21. The trade weighted average tariff is 3.40.

How to import from Lesotho?

Importing from Lesotho requires proper customs declarations, country of origin documentation, HS code classifications, and payment of the 15% tariff rate along with any other applicable duties and taxes. We are also working on building a comprehensive database of HS code classifications & a more comprehensive list of documentation requirements.

Does Lesotho offer preferential tariffs?

Manufacturers are accorded preferential treatment and granted blanket import rights for 12 months, with an additional grace period of three months. Lesotho also provides preferential tariffs in Line with SADC's tariff regime. This includes agreements including the EU- SADC Economic Partnership Agreement Tariff Rate Quota Utilization.
